The pledgor and the pledgee hereby agree to file this Application with the registrar to register the pledge of the mentioned securities in the company / mutual fund's securities holder register and agree in the term as follows :

Clause 1. When the obligation secured by the pledge is terminated or the pledge is released by the pledgor, the pledgee shall notify the registrar the revocation of the mentioned pledge of securities in order to revoke the pledge registered in the company / mutual fund's securities holder register.

Clause 2. In case that the mentioned pledge of securities is effective and the company / mutual fund announces to pay dividends or interest for securities pledged as the collateral, the pledgor and the pledgee agree that the registrar shall send the dividends or the interest to

the pledgor

the pledgee to pay for interest accrued by the pledgor and, if no accrued interest, to pay for the principle accrued thereby.

Clause 3. In case that the registration of pledge of securities is made after the closing date of the company / mutual fund's securities holder register for giving the right to receive dividends or interest at any time, if the mentioned company / mutual fund has not yet paid the dividends or the interest in accordance with such right, the pledgor and the pledgee agree that the registrar shall send the pledgor the dividends or the interest paid at such time. If the revocation of pledge of securities is made after the closing date of the company / mutual fund's securities holder register for giving the right to receive dividend or interest at anytime, if the mentioned company / mutual fund has not yet paid the dividends or the interest in accordance with such right. The pledgor and the pledge agree that the registrar shall send the person specified in clause 2 the dividends or the interest.

Clause 4. Enforcing the pledge, the pledgee shall state the condition that the purchasing of securities from an auction being subject to the Articles of Association of the company / mutual fund. In case that the person who is entitled to receive securities from the auction cannot register as the securities holder in accordance with the Articles of Association of the company / mutual fund, it shall be deemed that the enforcing of the pledge by auction is cancelled. The pledgee shall proceed with auctioning again so that such securities transfer is in compliance with the mentioned Articles of Association of the company / mutual fund.

Clause 5. The pledgor and the pledgee have acknowledged the substance of the condition relating to the right of securities holding of non-Thai holders in the Articles of Association of the company / mutual fund.

By this application, the pledgor and the pledgee have read and understood all of the contents therein that they are in compliance with our purposes, we hereby signed our names in the presence of witnesses thereof.
